The Southside Tomorrow Steering Committee invites all South Bethlehem serving organizations, residents, and business owners to propose community-driven projects for implementation between July 1, 2026 and September 30, 2027. All projects should focus on improving the quality of life for South Bethlehem residents and should align with at least one of the three priority areas identified by the Southside Tomorrow master plan (listed below).

Southside Tomorrow's commitment to community-driven initiatives is reflected in our flexible funding approach. We welcome proposals from a diverse range of entities, including non-profit organizations, businesses, and individual community members. This flexibility aims to empower all stakeholders to actively participate in shaping the future of South Bethlehem. Whether you represent an established organization, a local business, or are a passionate resident with a transformative idea, we encourage you to submit proposals that align with our priority areas.

In addition, Southside Tomorrow recognizes the strength that collaboration brings to community initiatives. To amplify impact, we encourage potential applicants to reach out to discuss their projects. If you have a project idea and wish to explore potential partnerships or align with similar initiatives, we are here to connect you with like-minded individuals and organizations.

About Southside Tomorrow

Southside Tomorrow is a six-year neighborhood revitalization program administered by Community Action Development Bethlehem in partnership with the City of Bethlehem, supported by the Pennsylvania Department of Community and Economic Development and with funding from Univest Bank & Trust Co., Embassy Bank for the Lehigh Valley, People's Security Bank and Trust, PPL Electric Utilities, and Provident Bank.

The Southside Tomorrow Master Plan 2021-2027 establishes goals and strategies to guide implementation of projects, which are selected and supervised by a Steering Committee comprised of community stakeholders and neighborhood residents, local government, small business owners, corporate contributors to the NPP, and local non-profits.

Through a comprehensive public input process, *Southside Tomorrow* identified three interconnected areas in which to invest resources and support collaborative projects: Housing Affordability and Quality, Public and Green Spaces, and Communication and Connectivity. Please note that the Steering Committee has identified Housing Affordability and Quality as the highest priority area for 2026-2027; therefore, projects in this category will receive additional points in the proposal review process.

Southside Tomorrow Priority Areas

Housing Affordability and Quality

Goal: South Bethlehem will have a variety of quality, affordable renter- and owner-occupied housing options and encourage development that meets the needs and wants of current and new residents, alike.

Strategies

1. Provide opportunities to engage and empower the community to have a choice in the decisions regarding new development and accessibility of affordable housing.
2. Provide opportunities for mixed-use, adaptive reuse development to increase quality, affordable rental-housing.
3. Provide opportunities for adaptive reuse development and rehabilitation to increase and maintain quality, affordable owner-occupied housing.
4. Invest in data collection initiatives that expand an understanding of how past, present, and future development in south Bethlehem impact its residents.

Public and Green Spaces

Goal: Preserve the integrity of existing public and green spaces while investing in practical and creative utilization of those spaces to foster community engagement while addressing community concerns.

Strategies

1. Implement neighborhood programs to connect residents with opportunities that build a sense of creative placemaking and community pride with communal spaces.
2. Utilize green spaces to address concerns of food insecurity and neighborhood access to fresh fruits and vegetables.

3. Address community concerns for youth engagement by expanding opportunities that connect youth with public/green spaces.
4. Invest in community image by improving upon venues for cleanliness and appearance.

Communication and Connectivity

Goal: Build a sense of collective community identity through modernized initiatives that enhance residents' belonging, pride, and fellowship.

Strategies

1. Create, maintain, and build on existing initiatives that enhance community connectivity and unification.
2. Foster neighborhood connectedness through community building events and celebratory gatherings.
3. Continue and enhance community input process to further garner ongoing community feedback.

1. Number of Southside residents served
2. Digital photos (and copies of the photo releases)
3. A short narrative detailing the program's successes and any challenges that were faced.
